



- The Education Chair was appointed (January 2021) to the SAF Educational Policy Review Committee. New SAF Accreditation Rules.
- The 2022 Biennial Conference on Undergraduate Education was held at the University of Nebraska-Lincoln School of Natural Resources in March, 2022 with the theme 'Inclusive Natural Resources Education'. Many NAUFRP institutions were represented at the conference and are working in many ways to make our educational programs more inclusive.
- **Fall 2022 Enrollments:** The Education Committee plans to send a short survey to find out about early indications of enrollment numbers in Forestry and Forest Resource programs.

- **Budget and Advocacy Committee (BAC)**
 - is actively developing priority areas for the FY 2024 Board on Agriculture Assembly (BAA) Unified Ask.
 - will meet during the APLU Annual Meeting November 6-8, 2022 in Denver, CO, where the BAC will vote on a final draft of the FY2024 requests.
- **Board on Natural Resources (BNR)**
 - 5 Sections: Ecology; Fish and Wildlife Resources; Forest Resources; Mineral and Energy Resources; Water Resources
 - Demonstrating the broader impact of the McIntire-Stennis Cooperative Forestry Program and other natural resource capacity funding has never been more important.
